BE it enacted by His Excellency the Governor and
Commander-in-Chief of the Colony of Cyprus as
follows :—

1.—(1) This Law may be cited as the Customs Tariff
(Amendment) (No. 3) Law, 1958, and shall be read as one with
the Customs Tariff Laws, 1954 to (No. 2) 1958 (hereinafter
referred to as "the principal Law"), and the principal Law and
this Law may together be cited as the Customs Tariff Laws, 1954
to (No. 3) 1958.

(2) This Law shall come into operation on the 28th day of
December, 1958.

2. Part I of the Second Schedule to the principal Law, as contained in the Customs Tariff (Amendment) Law, 1958, is hereby amended in relation to item number 313-01 :—

- (i) in sub-item (a) by substituting £11.450 mils for £8.750 mils in both the fifth and sixth columns.
- (ii) in sub-item (d) by substituting £11.450 mils for £8.750 mils in both the fifth and sixth columns.

A LAW TO AMEND THE GRAIN CONTROL LAWS, 1953 AND 1954.

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :—

1. This Law may be cited as the Grain Control (Amendment) Law, 1958, and shall be read as one with the Grain Control Law, 1953 and 1954 (hereinafter referred to as “ the principal Law ”), and the principal Law and this Law may together be cited as the Grain Control Laws, 1953 to 1958.

2. The definition of the word “ grain ” in section 2 of the principal Law is hereby amended by deleting the semi-colon at the end thereof and by inserting immediately after the word “ animal ” the following :—

“ and further includes flour (as defined in sub-section (2) of section 18 of this Law) ; ”.
