To amend and consolidate the Law relating to Contract.

1. This Law may be cited as the Contract Law.

Short title.

General rule of construction of Law. 2. (1) This Law shall be interpreted in accordance with the principles of legal interpretation obtaining in England, and expressions used in it shall be presumed, so far as is consistent with their context, and except as may be otherwise expressly provided, to be used with the meaning attaching to them in English law and shall be construed in accordance therewith.

Interpreta tion.

- (2) In this Law the following words and expressions are used in the following senses, unless a contrary intention appears from the context—
 - (a) when one person signifies to another his willingness to do or to abstain from doing anything, with a view to obtaining the assent of that other to such act or abstinence, he is said to make a proposal;
 - (b) when the person to whom the proposal is made signifies his assent thereto, the proposal is said to be accepted. A proposal, when accepted, becomes a promise;
 - (c) the person making the proposal is called the "promisor," and the person accepting the proposal is called the "promisee";
 - (d) when, at the desire of the promisor, the promisee or any other person has done or abstained from doing, or does or abstains from doing, or promises to do or to abstain from doing, something, such act or abstinence or promise is called a consideration for the promise;
 - (e) every promise and every act of promises, forming the consideration for each other, is an agreement;
 - (f) promises which form the consideration or part of the consideration for each other are called reciprocal promises;
 - (g) an agreement not enforceable by law is said to be void;
 - (h) an agreement enforceable by law is a contract;
 - (i) an agreement which is enforceable by law at the option of one or more of the parties thereto, but not at the option of the other or others, is a voidable contract;
 - (i) a contract which ceases to be enforceable by law becomes void when it ceases to be enforceable.

(3) "representatives" means the persons who by operation of law succeed to the property of a deceased person.

PART II.

OF THE COMMUNICATION, ACCEPTANCE AND REVOCATION OF PROPOSALS.

3. The communication of proposals, the acceptance of Communication, proposals, and the revocation of proposals and acceptances, acceptance respectively, are deemed to be made by any act or omission and revocation of the party proposing, accepting or revoking by which of proposals. he intends to communicate such proposal, acceptance or revocation, or which has the effect of communicating it.

4. (1) The communication of a proposal is complete Communication, when when it comes to the knowledge of the person to whom complete. it is made.

- (2) The communication of an acceptance is complete—
 - (a) as against the proposer, when it is put in a course of transmission to him, so as to be out of the power of the acceptor;
 - (b) as against the acceptor, when it comes to the knowledge of the proposer.
- (3) The communication of a revocation is complete—
 - (a) as against the person who makes it, when it is put into a course of transmission to the person to whom it is made, so as to be out of the power of the person who makes it;
 - (b) as against the person to whom it is made, when it comes to his knowledge.
- 5. A proposal may be revoked at any time before the Revocation communication of its acceptance is complete as against and accepthe proposer, but not afterwards.

An acceptance may be revoked at any time before the communication of the acceptance is complete as against the acceptor, but not afterwards.

6. A proposal is revoked—

Revocation, how made.

(a) by the communication of notice of revocation by the proposer to the other party;

- (b) by the lapse of the time prescribed in such proposal for its acceptance, or, if no time is so prescribed, by the lapse of a reasonable time, without communication of the acceptance;
- (c) by the failure of the acceptor to fulfil a condition precedent to acceptance; or
- (d) by the death or insanity of the proposer, if the fact of his death or insanity comes to the knowledge of the acceptor before acceptance.

Acceptance must be absolute.

- 7. In order to convert a proposal into a promise, the acceptance must—
 - (a) be absolute and unqualified;
 - (b) be expressed in some usual and reasonable manner, unless the proposal prescribes the manner in which it is to be accepted. If the proposal prescribes a manner in which it is to be accepted, and the acceptance is not made in such manner, the proposer may, within a reasonable time after the acceptance is communicated to him, insist that his proposal shall be accepted in the prescribed manner, and not otherwise; but if he fails to do so, he accepts the acceptance.

Acceptance by performing conditions, or receiving consideration.

8. Performance of the conditions of a proposal, or the acceptance of any consideration for a reciprocal promise which may be offered with a proposal, is an acceptance of the proposal.

Promises, express and implied.

9. In so far as the proposal or acceptance of any promise is made in writing or in words, the promise is said to be express. In so far as such proposal or acceptance is made otherwise than in writing or in words, the promise is said to be implied.

PART III.

OF CONTRACTS, VOIDABLE CONTRACTS AND VOID AGREEMENTS.

What agreements are contracts. 10. (1) All agreements are contracts if they are made by the free consent of parties competent to contract, for a lawful consideration and with a lawful object, and are not hereby expressly declared to be void, and may, subject to the provisions of this Law, be made in writing, or by word of mouth, or partly in writing and partly by word of mouth, or may be implied from the conduct of the parties.

(2) Nothing herein contained shall affect any Law in Saving. force in Cyprus, and not hereby expressly repealed, by which any contract is required to be made in writing or in the presence of witnesses, or any Law relating to the registration of documents.

- 11. (1) Subject to the provisions of subsection (2), Capacity to contract. every person is competent to contract who-2 of 7/56.
 - (a) is of sound mind; and
 - (b) is not disqualified from contracting by any Law.
- (2) The law in force in England for the time being relating to contracts to which an infant is a party shall apply to contracts to which a person who has not attained the age of eighteen years is a party:

Provided that a married person shall not be deemed to be incompetent to contract merely because such person has not attained the age of eighteen years.

12. A person is said to be of sound mind for the purpose What is a of making a contract if, at the time when he makes it, sound to for the he is capable of understanding it and of forming a rational purposes of contracting. judgment as to its effect upon his interests.

A person who is usually of unsound mind, but occasionally of sound mind, may make a contract when he is of sound mind.

A person who is usually of sound mind, but occasionally of unsound mind, may not make a contract when he is of unsound mind.

- 13. Two or more persons are said to consent when they "Consent" defined. agree upon the same thing in the same sense.
 - 14. Consent is said to be free when it is not caused by-

(a) coercion, as defined in section 15; or

consent " defined.

- (b) undue influence, as defined in section 16; or
- (c) fraud, as defined in section 17; or
- (d) misrepresentation, as defined in section 18; or
- (e) mistake subject to the provisions of sections 20, 21 and 22.

Consent is said to be so caused when it would not have been given but for the existence of such coercion, undue influence, fraud, misrepresentation or mistake.

" Coercion " defined.

Cap. 154.

15. (1) "Coercion" is the committing or threatening to commit, any act forbidden by the Criminal Code, or any amendment thereof, or the unlawful detaining, or threatening to detain, any property, to the prejudice of any person whatever, with the intention of causing any person to enter into an agreement.

Cap. 154.

(2) It is immaterial whether the Criminal Code, or any amendment thereof, is or is not in force in the place where the coercion is employed.

"Undue influence" defined.

- 16. (1) A contract is said to be induced by "undue influence" where the relations sushsisting between the parties are such that one of the parties is in a position to dominate the will of the other and uses that position to obtain an unfair advantage over the other.
- (2) In particular and without prejudice to the generality of the foregoing principle, a person is deemed to be in a position to dominate the will of another—
 - (a) where he holds a real or apparent authority over the other, or where he stands in a fiduciary relation to the other; or
 - (b) where he makes a contract with a person whose mental capacity is temporarily or permanently affected by reason of age, illness, or mental or bodily distress.
- (3) Where a person who is in a position to dominate the will of another, enters into a contract with him, and the transaction appears, on the face of it or on the evidence adduced, to be unconscionable, the burden of proving that such contract was not induced by undue influence shall lie upon the person in a position to dominate the will of the other.

" Fraud " defined.

- 17. (1) "Fraud" includes any of the following acts committed by a party to a contract, or with his connivance, or by his agent, with intent to deceive another party thereto or his agent, or to induce him to enter into the contract—
 - (a) the suggestion, as to a fact, of that which is not true by one who does not believe it to be true;

- (b) the active concealment of a fact by one having knowledge or belief of the fact;
- (c) a promise made without any intention of performing
- (d) any other act fitted to deceive;
- (e) any such act or omission as the law specially declares to be fraudulent.
- (2) Mere silence as to facts likely to affect the willingness of a person to enter into a contract is not fraud, unless the circumstances of the case are such that, regard being had to them, it is the duty of the person keeping silence to speak, or unless his silence is, in itself, equivalent to speech.
 - 18. "Misrepresentation" includes—

" Misrepresentation

- (a) the positive assertion, in a manner not warranted defined. by the information of the person making it, of that which is not true, though he believes it to be true:
- (b) any breach of duty which, without an intent to deceive, gains an advantage to the person committing it, or any one claiming under him, by misleading another to his prejudice or to the prejudice of any one claiming under him;
- (c) causing, however innocently, a party to an agreement to make a mistake as to the substance of the thing which is the subject to the agreement.
- 19. (1) When consent to an agreement is caused by Voidability coercion, fraud or misrepresentation, the agreement is a ments withcontract voidable at the option of the party whose consent out free consent. was so caused.

- (2) A party to a contract, whose consent was caused by fraud or misrepresentation, may, if he thinks fit, insist that the contract shall be performed, and that he shall be put in the position in which he would have been if the representations made had been true.
- (3) If such consent was caused by misrepresentation or by silence, fraudulent within the meaning of section 17, the contract, nevertheless, is not voidable, if the party whose consent was so caused had the means of discovering the truth with ordinary diligence.

(4) A fraud or misrepresentation which did not cause the consent to a contract of the party on whom such fraud was practised, or to whom such misrepresentation was made, does not render a contract voidable.

Power to set aside contract induced by undue influence.

- 20. (1) When consent to an agreement is caused by undue influence, the agreement is a contract voidable at the option of the party whose consent was so caused.
- (2) Any such contract may be set aside either absolutely or, if the party who was entitled to avoid it has received any benefit thereunder, upon such terms and conditions as to the Court may seem just.

Agreement void where both parties are under mistake as to matter of fact.

21. (1) Where both the parties to an agreement are under a mistake as to a matter of fact essential to the agreement, the agreement is void.

An erroneous opinion as to the value of the thing which forms the subject-matter of the agreement is not to be deemed a mistake as to a matter of fact.

Effect of mistakes as to law.

(2) A contract is not voidable because it was caused by a mistake as to any law in force in Cyprus; but a mistake as to a law not in force in Cyprus has the same effect as a mistake of fact.

Contract caused by mistake of one party as to matter of fact.

22. A contract is not voidable merely because it was caused by one of the parties to it being under a mistake as to a matter of fact.

What considerations and objects are lawful and what not.

- 23. The consideration or object of an agreement is lawful, unless-
 - (a) it is forbidden by law; or
 - (b) is of such a nature that, if permitted, it would defeat the provisions of any law; or
 - (c) is fraudulent; or
 - (d) involves or implies injury to the person or property of another; or
 - (e) the Court regards it as immoral, or opposed to public policy.

In each of these cases, the consideration or object of an agreement is said to be unlawful. Every agreement of which the object or consideration is unlawful is void.

Void Agreements.

24. If any part of a single consideration for one or Agreements more objects, or any one or any part of any one of several consideraconsiderations for a single object, is unlawful, the agreement tions and is void.

In any of these cases, such an agreement is a contract.

- (2) Nothing in this section shall affect the validity, as between the donor and donee, of any gift actually made.
- (3) An agreement to which the consent of the promisor is freely given is not void merely because the consideration is inadequate; but the inadequacy of the consideration may be taken into account by the Court in determining the question whether the consent of the promisor was freely given.

27. (1) Every agreement by which any one is restrained Agreement from exercising a lawful profession, trade, or business of of trade void. any kind, is to that extent void.

Saving of agreement not to carry on business of which good-will is sold; (2) (a) One who sells the good-will of a business may agree with the buyer to refrain from carrying on a similar business, within specified local limits, so long as the buyer or any person deriving title to the good-will from him, carries on a like business therein: Provided that such limits appear to the Court reasonable, regard being had to the nature of the business;

of agreement between partners prior to dissolution, (b) partners may, upon or in anticipation of a dissolution of the partnership, agree that some or all of them will not carry on a business similar to that of the partnership within such local limits as are referred to in the last preceding subsection;

or during continuance of partnership.

(c) partners may agree that some one or all of them will not carry on any business, other than that of the partnership, during the continuance of the partnership.

Agreements in restraint of legal proceedings void. 28. (1) Every agreement, by which any party thereto is restricted absolutely from enforcing his rights under or in respect of any contract, by the usual legal proceedings in the Courts, or which limits the time within which he may thus enforce his rights, is void to that extent.

Saving of contract to refer to arbitration dispute that may arise.

(2) This section shall not render illegal a contract by which two or more persons agree that any dispute which may arise between them in respect of any subject or class of subjects shall be referred to arbitration, and that only the amount awarded in such arbitration shall be recoverable in respect of the dispute so referred.

When such a contract has been made, legal proceedings may be brought for its specific performance, and if legal proceedings, other than for such specific performance, or for the recovery of the amount so awarded, are brought by one party to such contract against any other such party in respect of any subject which they have so agreed to refer, the existence of such contract shall be a bar to the legal proceedings.

Saving of contract to refer questions that have already arisen. (3) This section shall not render illegal any contract in writing, by which two or more persons agree to refer to arbitration any question between them which has already arisen, or affect any provision of any law in force for the time being as to references to arbitration.

29. Agreements, the meaning of which is not certain, Agreements or capable of being made certain, are void.

30. Agreements by way of wager are void; and no Agreements legal proceedings shall be brought for recovering anything wager void. alleged to be won on any wager, or entrusted to any person to abide the result of any game or other uncertain event on which any wager is made.

PART IV.

OF CONTINGENT CONTRACTS.

31. A "contingent contract" is a contract to do or "Contingent contract" not to do something, if some event, collateral to such defined. contract, does or does not happen.

(2) Contingent contracts to do or not to do anything if a specified uncertain event does not happen within a fixed time may be enforced by law when the time fixed has expired and such event has not happened, or, before the time fixed has expired, if it becomes certain that such event will not happen.

Agreement contingent on impossible events void.

36. Contingent agreements to do or not to do anything, if an impossible event happens, are void, whether the impossibility of the event is known or not to the parties to the agreement at the time when it is made.

PART V.

Of the Performance of Contracts.

Contracts Which Must be Performed.

Obligation of parties to contracts.

37. (1) The parties to a contract must either perform, or offer to perform, their respective promises, unless such performance is dispensed with or excused under the provisions of this Law, or of any other Law.

When promises binding on representatives of promisors.

(2) Promises bind the representatives of the promisors in case of the death of such promisors before performance, unless a contrary intention appears from the contract.

Effect of refusal to accept offer of performance.

- 38. (1) Where a promisor has made an offer of performance to the promisee, and the offer has not been accepted, the promisor is not responsible for non-performance, nor does he thereby lose his rights under the contract.
 - (2) Every such offer must fulfil the following conditions—
 - (a) it must be unconditional;
 - (b) it must be made at a proper time and place, and under such circumstances that the person to whom it is made may have a reasonable opportunity of ascertaining that the person by whom it is made is able and willing there and then to do the whole of what he is bound by his promise to do;
 - (c) if the offer is an offer to deliver anything to the promisee, the promisee must have a reasonable opportunity of seeing that the thing offered is the thing which the promisor is bound by his promise to deliver.
- (3) An offer to one of several joint promisees has the same legal consequences as an offer to all of them.

Effect of refusal of party to perform promise wholly. 39. When a party to a contract has refused to perform, or disabled himself from performing, his promise in its entirety, the promisee may put an end to the contract, unless he has signified, by words or conduct, his acquiescence in its continuance.

By Whom Contracts Must be Performed

40. (4) Nothing in this section shall prevent a surety from Saving. recovering from his principal, payments made by the surety on behalf of the principal, or entitle the principal to recover anything from the surety on account of payments made by the principal.

44. Where two or more persons have made a joint Effect of release of promise, a release of one of such joint promisors by the one joint promisee does not discharge the other joint promisor or promisor. joint promisors; neither does it free the joint promisor so released from responsibility to the other joint promiser or joint promisors. 2(2)

Devolution of joint rights.

45. When a person has made a promise to two or more persons jointly, then, unless a contrary intention appears from the contract, the right to claim performance rests, as between him and them, with them during their joint lives, and, after the death of any of them, with the representative of such deceased person jointly with the survivor or survivors, and, after the death of the last survivor, with the representatives of all jointly.

Time and Place for Performance.

Time for performance of promise where no application is to be made and no time is specified.

46. Where, by the contract, a promisor is to perform his promise without application by the promisee, and no time for performance is specified, the engagement must be performed within a reasonable time.

The question "what is a reasonable time" is, in each particular case, a question of fact.

Time and place for performance of promise where time is specified and no application to be made.

47. When a promise is to be performed on a certain day, and the promisor has undertaken to perform it without application by the promisee, the promisor may perform it at any time during the usual hours of business on such day and at the place at which the promise ought to be performed.

Application for performance on certain day to be at proper time and place.

48. When a promise is to be performed on a certain day, and the promisor has not undertaken to perform it without application by the promisee, it is the duty of the promisee to apply for performance at a proper place and within the usual hours of business.

The question "what is a proper time and place" is, in each particular case, a question of fact.

Place for performance of promise where no application to be made and no place

49. When a promise is to be performed without application by the promisee, and no place is fixed for the performance of it, it is the duty of the promisor to apply to the promisee to appoint a reasonable place for the performance. performance of the promise, and to perform it at such place.

50. The performance of any promise may be made in Performance any manner, or at any time, which the promisee prescribes or at time or sanctions.

prescribed or sanctioned by promise.

Performance of Reciprocal Promises.

51. When a contract consists of reciprocal promises to be simultaneously performed, no promisor need perform perform, his promise unless the promisee is ready and willing to unless perform his reciprocal promise.

Promisor not bound to reciprocal promisee ready and willing to perform.

52. Where the order in which reciprocal promises are Order of to be performed is expressly fixed by the contract, they of reciprocal shall be performed in that order; and, where the order promises. is not expressly fixed by the contract, they shall be performed in that order which the nature of the transaction requires.

53. 54. Effect of such failure when time is not essential.

(2) If it was not the intention of the parties that time should be of the essence of the contract, the contract does not become voidable by the failure to do such thing at or before the specified time; but the promisee is entitled to compensation from the promisor for any loss occasioned to him by such failure.

Effect of acceptance of performance at time other than that agreed upon.

(3) If, in case of a contract voidable on account of the promisor's failure to perform his promise at the time agreed, the promisee accepts performance of such promise at any time other than that agreed, the promisee cannot claim compensation for any loss occasioned by the nonperformance of the promise at the time agreed, unless, at the time of such acceptance, he gives notice to the promisor of his intention to do so.

- **56.** (1) An agreement to do an act impossible in itself is void.
- (2) A contract to do an act which, after the contract is made, becomes impossible, or, by reason of some event which the promisor could not prevent, unlawful, becomes void when the act becomes impossible or unlawful.
- (3) Where one person has promised to do something which he knew, or, with reasonable diligence, might have known, and which the promisee did not know to be impossible or unlawful, such promisor must make compensation to such promisee for any loss which such promisee sustains through the non-performance of the promise.

Reciprocal promise to do things legal, and also other things illegal.

57. Where persons reciprocally promise, firstly, to do certain things which are legal, and, secondly, under specified circumstances, to do certain other things which are illegal, the first set of promises is a contract, but the second is a void agreement.

Alternative promise, one illegal.

58. In the case of an alternative promise, one branch branch being of which is legal and the other illegal, the legal branch alone can be enforced.

Appropriation of Payments.

Application of payment where debt to be discharged is indicated.

59. Where a debtor, owing several distinct debts to one person, makes a payment to him, either with express intimation, or under circumstances implying that the payment is to be applied to the discharge of some particular debt, the payment, if accepted, must be applied accordingly.

60. Effect of neglect of promisee to afford promisor reasonable facilities for performance. 67. If any promisee neglects or refuses to afford the promisor reasonable facilities for the performance of his promise, the promisor is excused by such neglect or refusal as to any non-performance caused thereby.

PART VI.

OF CERTAIN RELATIONS RESEMBLING THOSE CREATED BY CONTRACT.

Claim for necessaries supplied to person incapable of contracting, or on his account. 68. If a person, incapable of entering into a contract, or, any one whom he is legally bound to support, is supplied by another person with necessaries suited to his condition in life, the person who has furnished such supplies is entitled to be reimbursed from the property of such incapable person.

Reimbursement of person paying money due by another in payment of which he is interested. Obligation of person enjoying benefit of non-gratuitous act.

69. A person who is interested in the payment of money which another is bound by law to pay, and who therefore pays it, is entitled to be reimbursed by the other.

Responsibility of finder of goods.

70. Where a person lawfully does anything for another person, or delivers anything to him, not intending to do so gratuitously, and such other person enjoys the benefit thereof, the latter is bound to make compensation to the former in respect of, or to restore, the thing so done or delivered.

71. A person who finds goods belonging to another and takes them into his custody, is subject to the same responsibility as a bailee.

Liability of person to whom money is paid, or thing delivered, by mistake or under coercion.

72. A person to whom money has been paid, or anything delivered, by mistake or under coercion, must repay or return it.

PART VII.

OF THE CONSEQUENCES OF BREACH OF CONTRACT.

Compensation for loss or damage caused by breach of contract. 73. (1) When a contract has been broken, the party who suffers by such breach is entitled to receive, from the party who has broken the contract, compensation for any loss or damage caused to him thereby, which naturally arose in the usual course of things from such breach, or which the parties knew, when they made the contract, to be likely to result from the breach of it.

Such compensation is not to be given for any remote and indirect loss or damage sustained by reason of the breach.

74. (2) When any person enters into any bailbond, recognisance or other instrument of the same nature, or, under the provisions of any Law, or under the orders of the Government of Cyprus, gives any bond for the performance of any public duty or act in which the public are interested, he shall be liable, upon breach of the condition of any such instrument, to pay the whole sum mentioned therein:

Provided that a person who enters into a contract with Government does not necessarily thereby undertake any public duty, or promise to do an act in which the public are interested.

75. A person who rightly rescinds a contract is entitled contract to compensation for any damage which he has sustained entitled to through the non-fulfilment of the contract.

PART VIII.

OF SPECIFIC PERFORMANCE OF CONTRACTS.

Specific performance of contracts and requisites thereof.

- **76.** (1) A contract shall be capable of being specifically enforced by the Court if—
 - (a) it is not a void contract under this or any other Law; and
 - (b) it is expressed in writing; and
 - (c) it is signed at the end thereof by the party to be charged therewith; and
 - (d) the Court considers, having regard to all the circumstances, that the enforcement of specific performance of the contract would not be unreasonable or otherwise inequitable or impracticable.

(2) Nothing herein contained shall affect the specific performance of contracts for the sale of immovable property under the provisions of the Sale of Land (Specific Performance) Law, or any amendment thereof.

PART IX.

OF THE REQUIREMENTS OF CONTRACTS RELATING TO CERTAIN MATTERS.

Requirements for leases and contracts made in consideration of marriage. 2 of 6/59.

- 77. (1) Contracts relating to leases of immovable property for any term exceeding one year shall not be valid and enforceable unless—
 - (a) expressed in writing; and
 - (b) signed at the end thereof, in the presence of at least two witnesses themselves competent to contract who have subscribed their names as witnesses, by each party to be charged therewith or by a person who is himself competent to contract and who has been duly authorised to sign on behalf of such party.
- (2) Contracts relating to obligations in consideration of marriage shall not be valid and enforceable unless—
 - (a) expressed in writing; and
 - (b) signed at the end thereof, in the presence of at least two witnesses themselves competent to contract who have subscribed their names as witnesses, by each party to be charged therewith

or by a person who is himself competent to contract and who has been duly authorised to sign on behalf of such party:

Provided that this subsection shall not apply to obligations in consideration of marriage between Moslems incurred in accordance with the practice prevailing in the Turkish Family Courts.

PART X.

OF BONDS IN CUSTOMARY FORM.

78. A "bond in customary form" is a promise in writing made by one person to another signed by the maker in the form, presence of at least two witnesses themselves competent to contract, engaging to pay, on demand or at a fixed or "Creditor" determinable future time, a sum of money to a person defined, and specified therein, together with interest at a rate fixed of bond. therein not exceeding nine per centum per annum and, in the event of any legal proceedings thereon, the costs thereof, and stating therein the consideration for which it is given.

The person who makes the promise is called the "debtor"; the person to whom the promise is made is called the "creditor."

79. A bond in customary form is not void by reason only Bond that it is secured by a guarantee or by a pledge or by guarantee, mortgage of immovable property and contains stipulations pledge or mortgage. relating thereto.

80. Whenever any legal proceedings are taken on a bond Conclusivein customary form, the contents of such bond shall be contents of conclusive evidence of the facts therein stated:

Provided that in any such proceedings it shall be a good defence to prove that the signature of the debtor or of any other party to the bond is not in fact the signature of such debtor or party or that the bond has been obtained by, or in circumstances amounting to, coercion or fraud.

81. Nothing herein contained shall, in respect of bonds in customary form, affect any power given or exercisable by or under the provisions of any of the following Laws or any amendments thereof—

(a) the Usury (Farmers) Law,

PART XI.

OF INDEMNITY AND GUARANTEE.

"Contract of indemnity" defined.

82. A contract by which one party promises to save the other from loss caused to him by the conduct of the promisor himself, or by the conduct of any other person, is called a "contract of indemnity."

Right of indemnity-holder when sued.

- 83. The promisee in a contract of indemnity, acting within the scope of his authority, is entitled to recover from the promisor—
 - (a) all damages which he may be compelled to pay in any legal proceedings in respect of any matter to which the promise to indemnify applies;
 - (b) all costs which he may be compelled to pay in any such legal proceedings if, in bringing or defending them, he did not contravene the orders of the promisor, and acted as it would have been prudent for him to act in the absence of any contract of indemnity, or if the promisor authorised him to bring or defend the legal proceedings;
 - (c) all sums which he may have paid under the terms of any compromise of any such legal proceedings, if the compromise was not contrary to the orders of the promisor, and was one which it would have been prudent for the promisee to make in the absence of any contract of indemnity, or if the promisor authorised him to compromise the legal proceedings.

"Contract of guarantee," "surety," "principal debtor," and "creditor." 84. A "contract of guarantee" is a contract to perform the promise, or discharge the liability, of a third person in case of his default. The person who gives the guarantee is called the "surety"; the person in respect of whose default the guarantee is given is called the "principal debtor," and the person to whom the guarantee is given is called the "creditor."

Consideration for guarantee. 85. Anything done, or any promise made, for the benefit of the principal debtor may be a sufficient consideration to the surety for giving the guarantee.

86. The liability of the surety is co-extensive with that Surety's liability. of the principal debtor, unless it is otherwise provided by the contract.

87. A guarantee which extends to a series of transactions "Continuing is called a "continuing guarantee."

88. A continuing guarantee may at any time be revoked Revocation of continuing by the surety, as to future transactions, by notice to the guarantee. creditor.

89. The death of the surety operates, in the absence of Revocation any contract to the contrary, as a revocation of a continuing guarantee by guarantee, so far as regards future transactions.

90. 93. A contract between the creditor and the principal creditor debtor, by which the creditor makes a composition with, or compounds promises to give time to, or not to sue, the principal debtor, time to, or discharges the surety, unless the surety assents to such agrees not to contract.

Discharge of surety when with, gives sue principal debtor.

Surety not discharged when agreement made with third person to give time to principal debtor.

94. Where a contract to give time to the principal debtor is made by the creditor with a third person, and not with the principal debtor, the surety is not discharged.

Creditor's forbearance to sue does surety.

95. Mere forbearance on the part of the creditor to sue the principal debtor or to enforce any other remedy against him does not, in the absence of any provision in the to sue does not discharge guarantee to the contrary, discharge the surety.

Release of one cosurety does others.

96. Where there are co-sureties, a release by the creditor of one of them does not discharge the others; neither does not discharge it free the surety so released from his responsibility to the other sureties.

Discharge of surety by or omission impairing surety's eventual remedy.

97. If the creditor does any act which is inconsistent with creditor's act the rights of the surety, or omits to do any act which his duty to the surety requires him to do, and the eventual remedy of the surety himself against the principal debtor is thereby impaired, the surety is discharged.

Rights of surety on payment or performance.

98. Where a guaranteed debt has become due, or default of the principal debtor to perform a guaranteed duty has taken place, the surety, upon payment or performance of all that he is liable for, is invested with all the rights which the creditor had against the principal debtor.

Surety's right to benefit of creditor's securities.

99. (1) A surety is entitled to the benefit of every security which the creditor has against the principal debtor at the time when the contract of suretyship is entered into, whether the surety knows of the existence of such security or not; and, if the creditor loses or, without the consent of the surety, parts with such security, the surety is discharged to the extent of the value of the security.

Saving. Cap. 6.

(2) Nothing in this or in the last preceding section contained shall affect the provisions of the Civil Procedure Law, or any amendment thereof.

Guarantee obtained by misrepresentation invalid.

100. Any guarantee which has been obtained by means of misrepresentation made by the creditor, or with his knowledge and assent, concerning a material part of the transaction, is invalid.

101. Any guarantee which the creditor has obtained by Guarantee means of keeping silence as to material circumstance is concealment invalid.

102. Where a person gives a guarantee upon a contract Guarantee that the creditor shall not act upon it until another person that creditor has joined in it as co-surety, the guarantee is not valid if shall not act that other person does not join.

on it until co-surety

103. In every contract of guarantee there is an implied Implied promise by the principal debtor to indemnify the surety; indemnify and the surety is entitled to recover from the principal surety. debtor whatever sum he has rightfully paid under the guarantee, but no sums which he has paid wrongfully.

104. Where two or more persons are co-sureties for the Co-sureties same debt or duty, either jointly or severally, and whether contribute under the same or different contracts, and whether with or equally. without the knowledge of each other, the co-sureties, in the absence of any contract to the contrary, are liable, as between themselves, to pay each an equal share of the whole debt, or of that part of it which remains unpaid by the principal debtor.

105. Co-sureties who are bound in different sums are Liability of liable to pay equally as far as the limits of their respective bound in obligations permit.

PART XII.

OF BAILMENT.

106. (1) In this Part of this Law—

- (a) "goods" means every kind of movable property bailment, and includes bills of exchange, promissory "bailor," notes, bonds whether in customary form or not "bailee" other than those secured by mortgage of defined. immovable property, share certificates or share warrants for shares in a company;
 - "company" means a limited liability company formed under the provisions of the Companies Law, or any amendment thereof, Cap. 113. or an anonyme company originally formed under the provisions of the Ottoman Commercial Code;

"Goods,"

- (b) a "bailment" is the delivery of goods by one person to another for some purpose, upon a contract that they shall, when the purpose is accomplished, be returned or otherwise disposed of according to the directions of the person delivering them. The person delivering the goods is called the "bailor." The person to whom they are delivered is called the "bailee."
- (2) If a person already in possession of the goods of another contracts to hold them as a bailee, he thereby becomes the bailee, and the owner becomes the bailor, of such goods although they may not have been delivered by way of bailment.

Delivery to bailee, how made.

107. The delivery to the bailee may be made by doing anything which has the effect of putting the goods in the possession of the intended bailee or of any person authorised to hold them on his behalf.

Bailor's duty to disclose faults in goods bailed.

- 108. (1) The bailor is bound to disclose to the bailee faults in the goods bailed, of which the bailor is aware, and which materially interfere with the use of them, or expose the bailee to extraordinary risks; and, if he does not make such disclosure, he is responsible for damage arising to the bailee directly from such faults.
- (2) If the goods are bailed for hire, the bailor is responsible for such damage, whether he was or was not aware of the existence of such faults in the goods bailed.

Care to be taken by bailee.

109. In all cases of bailment the bailee is bound to take as much care of the goods bailed to him as a man of ordinary prudence would, under similar circumstances, take of his own goods of the same bulk, quality and value as the goods bailed.

Bailee when not liable for loss, etc., of thing bailed. 110. The bailee, in the absence of any special contract, is not responsible for the loss, destruction or deterioration of the thing bailed, if he has taken the amount of care of it described in the last preceding section.

Termination of bailment by bailee's act inconsistent with conditions.

111. A contract of bailment is voidable at the option of the bailor, if the bailee does any act with regard to the goods bailed, inconsistent with the conditions of the bailment.

112. If the bailee makes any use of the goods bailed, Liability of which is not according to the conditions of the bailment, he making unis liable to make compensation to the bailor for any damage authorised arising to the goods from or during such use of them.

113. If the bailee, with the consent of the bailor, mixes Effect of the goods of the bailor with his own goods, the bailor and with bailor's the bailee shall have an interest, in proportion to their consent, of his goods respective shares, in the mixture thus produced.

mixture, with bailee's.

114. If the bailee, without the consent of the bailor, mixes the goods of the bailor with his own goods, and the without goods can be separated or divided, the property in the goods bailor's remains in the parties respectively; but the bailee is bound when the to bear the expense of separation or division, and any goods can be separated. damage arising from the mixture.

115. If the bailee, without the consent of the bailor, mixes the goods of the bailor with his own goods, in such a without manner that it is impossible to separate the goods bailed bailor's from the other goods and deliver them back, the bailor is when the entitled to be compensated by the bailee for the loss of the goods cannot be separated. goods.

116. Where, by the conditions of the bailment, the goods Repayment by bailor of are to be kept or to be carried, or to have work done upon necessary them by the bailee for the bailor, and the bailee is to receive no remuneration, the bailor shall repay to the bailee the necessary expenses incurred by him for the purpose of the bailment.

117. The lender of a thing for use may at any time require Restoration its return, if the loan was gratuitous, even though he lent gratuitously. it for a specified time or purpose. But, if, on the faith of such loan made for a specified time or purpose, the borrower has acted in such a manner that the return of the thing lent before the time agreed upon would cause him loss exceeding the benefit actually derived by him from the loans, the lender must, if he compels the return, indemnify the borrower for the amount in which the loss so occasioned exceeds the benefit so derived.

Return of goods bailed of time or accomplishment of purpose.

118. It is the duty of the bailee to return, or deliver on expiration according to the bailor's directions, the goods bailed, without demand, as soon as the time for which they were bailed has expired, or the purpose for which they were bailed has been accomplished.

Bailee's responsibility when goods are not refurned

119. If, by the default of the bailee, the goods are not returned, delivered or tendered at the proper time, he is responsible to the bailor for any loss, destruction or deterioration of the goods from that time.

Termination of gratuitous bailment by death.

120. A gratuitous bailment is terminated by the death either of the bailor or of the bailee.

Bailor entitled to increase or profit from goods bailed.

121. In the absence of any contract to the contrary, the bailee is bound to deliver to the bailor, or according to his directions, any increase or profit which may have accrued from the goods bailed.

Bailor's responsibility to bailee.

122. The bailor is responsible to the bailee for any loss which the bailee may sustain by reason that the bailor was not entitled to make the bailment, or to receive back the goods or to give directions respecting them.

Bailment by several joint owners.

123. If several joint owners of goods bail them, the bailee may deliver them back to, or according to the directions of, one joint owner without the consent of all, in the absence of any agreement to the contrary.

Bailee not responsible on redelivery to bailor

124. If the bailor has no title to the goods, and the bailee, in good faith, delivers them back to, or according to the directions of, the bailor, the bailee is not responsible to without title. the owner in respect of such delivery.

Right of third person claiming goods bailed.

125. If a person other than the bailor, claims goods bailed, he may take legal proceedings to stop the delivery of the goods to the bailor, and to decide the title to the goods.

Right of finder of goods; may sue for specific reward offered.

126. The finder of goods has no right to sue the owner for compensation for trouble and expense voluntarily incurred by him to preserve the goods and to find out the owner; but he may retain the goods against the owner until he receives such compensation; and, where the owner has offered a specific reward for the return of goods lost, the

finder may sue for such reward, and may retain the goods until he receives it.

127. When a thing which is commonly the subject of When finder sale is lost, if the owner cannot with reasonable diligence be of thing commonly found, or if he refuses, upon demand, to pay the lawful on sale may charges of the finder, the finder may sell it-

- (a) when the thing is in danger of perishing or of losing the greater part of its value; or
- (b) when the lawful charges of the finder, in respect of the thing found, amount to two-thirds of its
- 128. Where the bailee has, in accordance with the purpose Bailee's of the bailment, rendered any service involving the exercise particular lien. of labour or skill in respect of the goods bailed, he has, in the absence of a contract to the contrary, a right to retain such goods until he receives due remuneration for the services he has rendered in respect of them.

129. Bankers, factors and wharfingers, may, in the General lien absence of a contract to the contrary, retain, as a security factors and for a general balance of account, any goods bailed to them; wharfingers. but no other persons have a right to retain, as a security for such balance, goods bailed to them, unless there is an express contract to that effect.

Bailments of Pledges.

130. The bailment of goods as security for payment of a "Pledge," but or performance of a promise is called "pledge." The "pawnor" debt or performance of a promise is called "pledge." The and bailor is in this case called the "pawnor." The bailee is "pawnee" defined. called the "pawnee."

131. The pawnee may retain the goods pledged, not only Pawnee's for payment of the debt or the performance of the promise, right or retainer. but for the interest of the debt, and all necessary expenses incurred by him in respect of the possession or for the preservation of the goods pledged.

132. The pawnee shall not, in the absence of a contract promise to that effect, retain the goods pledged for any debt or that for promise other than the debt or promise for which they are which goods pledged; but such contract, in the absence of anything to Presumption the contrary, shall be presumed in regard to subsequent in case of advances made by the pawnee.

Pawnee not to retain for debt or other than subsequent advances.

Pawnee's right as to extraordinary expenses incurred. 133. The pawnee is entitled to receive from the pawnor extraordinary expenses incurred by him for the preservation of the goods pledged.

Pawnee's right where pawnor makes default.

- 134. (1) If the pawnor makes default in payment of the debt, or performance, at the stipulated time of the promise, in respect of which the goods were pledged, the pawnee may bring legal proceedings against the pawnor upon the debt or promise, and retain the goods pledged as a collateral security; or he may sell the thing pledged, on giving the pawnor reasonable notice of the sale.
- (2) If the proceeds of such sale are less than the amount due in respect of the debt or promise, the pawnor is still liable to pay the balance. If the proceeds of the sale are greater than the amount so due, the pawnee shall pay over the surplus to the pawnor.

Defaulting pawnor's right to redeem. 135. If a time is stipulated for the payment of the debt, or performance of the promise, for which the pledge is made, and the pawnor makes default in payment of the debt or performance of the promise at the stipulated time, he may redeem the goods pledged at any subsequent time before the actual sale of them; but he must, in that case, pay, in addition, any expenses which have arisen from his default.

Pledge by possessor of goods, or of documentary title to goods. 136. A person who is in possession of any goods, or of any bill of lading, dock-warrant, warehouse-keeper's certificate, wharfinger's certificate, or warrant or order for delivery, or any other document of title to goods, may make a valid pledge of such goods or documents:

Provided that the pawnee acts in good faith, and under circumstances which are not such as to raise a reasonable presumption that the pawner is acting improperly:

Provided also that such goods or documents have not been obtained from their lawful owner, or from any person in lawful custody of them, by means of an offence or fraud.

Pledge where pawnor has only a limited interest

137. Where a person pledges goods in which he has only a limited interest, the pledge is valid to the extent of that interest.

Requirements for a

pledge of bills of

exchange,

138. (1) A pledge of—

- (a) bills of exchange, or
- (b) promissory notes, or
- (c) bonds, whether in customary form or not, other notes, etc. than those secured by mortgage of immovable property, or

(d) share certificates or share warrants for shares in a company, as security for payment of a debt or performance of a promise,

shall not be valid and enforceable unless the contract of pledge-

- (i) is expressed in writing, and
- (ii) is signed at the end thereof by the pawnor, and
- (iii) is made in the presence of at least two witnesses themselves competent to contract and subscribed by them with their names as witnesses.
- (2) A pledge of share certificates or share warrants for Additional shares in a company transferable otherwise than by delivery for pledge of shall not be valid and enforceable unless, in addition to the shares. requirements of the preceding subsection—

- (a) notice of such pledge, together with a certified copy of the contract of pledge, is given by the pawnee to the company, and
- (b) the company shall have made a memorandum of such pledge in the register of shareholders against the shares in respect of which the notice shall have been given, and
- (c) the company shall have delivered to the pawnee a certificate that a memorandum of such pledge has been made in the register as aforesaid.
- 139. In the absence of any stipulations to the contrary Pawnee's contained in a contract of pledge made in accordance with pawnor the provisions of the last preceding section, the pawnee makes shall, in case the pawnor makes default in the payment of contract of the debt or the performance of the promise at the stipulated pledge made time, have the same rights and remedies on the pledge accordance against third parties as the pawnor himself would have had with last but for the contract of pledge, and all payments made to section. the pawnee by third parties on such pledge shall be as valid and effective as if made to the pawnor himself.

Legal Proceedings by Bailees or Bailors against Wrong-doers.

Legal proceedings by bailor or bailee against wrong-doer 140. If a third person wrongfully deprives the bailee of the use or possession of the goods bailed, or does them any injury, the bailee is entitled to use such remedies as the owner might have used in the like case if no bailment had been made; and either the bailor or the bailee may bring legal proceedings against a third person for such deprivation or injury.

Apportionment of relief or compensation obtained by such legal proceedings. 141. Whatever is obtained by way of relief or compensation in any such legal proceedings shall, as between the bailor and the bailee, be dealt with according to their respective interests.

PART XIII.

AGENCY.

Appointment and Authority of Agents.

" Agent " and " principal " defined. 142. An "agent" is a person employed to do any act for another or to represent another in dealings with third persons. The person for whom such act is done, or who is so represented, is called the "principal."

Who may employ agent.

143. Any person who is competent to contract may employ an agent.

Who may be an agent.

144. As between the principal and third persons any person may become an agent, but no person who is not competent to contract can become an agent, so as to be responsible to his principal according to the provisions in that behalf herein contained.

Consideration not necessary.

145. No consideration is necessary to create an agency.

Agent's authority may be expressed or implied. Definitions of express and implied authority.

- 146. The authority of an agent may be expressed or implied.
- 147. An authority is said to be express when it is given by words spoken or written. An authority is said to be implied when it is to be inferred from the circumstances of the case; and things spoken or written, or the ordinary course of dealing, may be accounted circumstances of the case.

148. (1) An agent having an authority to do an act has Extent of authority to do every lawful thing which is necessary in authority. order to do such act.

- (2) An agent having an authority to carry on a business has authority to do every lawful thing necessary for the purpose, or usually done in the course of conducting such
- 149. An agent has authority, in an emergency, to do all Agent's authority such acts for the purpose of protecting his principal from in an loss as would be done by a person of ordinary prudence, in emergency. his own case, under similar circumstances.

Sub-agents.

150. An agent cannot lawfully employ another to per- When agent form acts which he has expressly or impliedly undertaken delegate. to perform personally, unless by the ordinary custom of trade a sub-agent may, or, from the nature of the agency, a sub-agent must, be employed.

151. A "sub-agent" is a person competent to contract, employed by, and acting under the control of, the original agent in the business of the agency.

"Sub-agent"

152. (1) When a sub-agent is properly appointed, the Repression of principal is, so far as regards third persons, represented by principal by the sub-agent, and is bound by and responsible for his acts, properly as if he were an agent originally appointed by the principal. appointed.

Representa-

(2) The agent is responsible to the principal for the acts Agent's respons. of the sub-agent.

bility for sub-agent. Sub-agent's

- (3) The sub-agent is responsible for his acts to the agent, but not to the principal, except in case of fraud or wilful bility. wrong.
- 153. Where an agent, without having authority to do so, Agent's has appointed a person to act as a sub-agent, the agent bility for stands towards such person in the relation of a principal to sub-agent an agent, and is responsible for his acts both to the principal without and to third persons; the principal is not represented by or authority. responsible for the acts of the person so employed, nor is that person responsible to the principal.

Relation between. person duly appointed by agent to act in business of agency.

154. Where an agent, holding an express or implied principal and authority to name another person to act for the principal in the business of the agency, has named another person accordingly, such person is not a sub-agent, but an agent of the principal for such part of the business of the agency as is entrusted to him.

Agent's duty in naming such person.

155. In selecting such agent for his principal, an agent is bound to exercise the same amount of discretion as a man of ordinary prudence would exercise in his own case; and if he does this he is not responsible to the principal for the acts or negligence of the agent so selected.

Ratification.

Right of person as to acts done for him without his authority Effect of ratification.

156. Where acts are done by one person on behalf of another, but without his knowledge or authority, he may elect to ratify or to disown such acts. If he ratify them, the same effects will follow as if they had been performed by his authority.

Ratification may be expressed or implied.

157. Ratification may be expressed or may be implied in the conduct of the person on whose behalf the acts are done.

Knowledge requisite for valid ratification. Effect of ratifying unauthorised act forming part of a transaction. Ratification of unauthorised act cannot injure

third person.

- 158. No valid ratification can be made by a person whose knowledge of the facts of the case is materially defective.
- 159. A person ratifying any unauthorised act done on his behalf ratifies the whole of the transaction of which such act formed a part.
- 160. An act done by one person on behalf of another, without such other person's authority, which, if done with authority, would have the effect of subjecting a third person to damages, or of terminating any right or interest of a third person, cannot, by ratification, be made to have such effect.

Revocation of Authority.

Termination of agency.

161. An agency is terminated by the principal revoking his authority; or by the agent renouncing the business of the agency; or by the business of the agency being completed; or by either the principal or agent dying or becoming of unsound mind; or by the principal being adjudicated a bankrupt or insolvent under the provisions of any Law for the time being in force relating to bankruptcy or insolvency.

162. Where the agent has himself an interest in the Termination property which forms the subject-matter of the agency, where agent the agency cannot, in the absence of an express contract, be terminated to the prejudice of such interest.

interest in subject-

163. The principal may, save as is otherwise provided by When the last preceding section, revoke the authority given to his may revoke agent at any time before the authority has been exercised agent's so as to bind the principal.

principal authority.

164. The principal cannot revoke the authority given to his agent after the authority has been partly exercised so far as regards such acts and obligations as arise from acts already done in the agency.

Revocation authority has been partly exercised.

165. Where there is an express or implied contract that the agency should be continued for any period of time, the revocation principal must make compensation to the agent, or the by principal agent to the principal, as the case may be, for any previous ation by revocation or renunciation of the agency without sufficient cause.

Compensa-

166. Reasonable notice must be given of such revocation Notice of revocation or or renunciation; otherwise the damage thereby resulting renunciation. to the principal or the agent, as the case may be, must be made good to the one by the other.

167. Revocation and renunciation may be expressed or may be implied in the conduct of the principal or agent ation may be respectively.

Revocation and renunciexpressed or implied.

168. The termination of the authority of an agent does not, so far as regards the agent, take effect before it becomes of agent's known to him, or, so far as regards third persons, before it takes effect becomes known to them.

When termination as to agent, and as to third persons tion of

169. When an agency is terminated by the principal dying Agent's duty or becoming of unsound mind, the agent is bound to take, on behalf of the representatives of his late principal, all agency by reasonable steps for the protection and preservation of the principal's interests entrusted to him.

insanity.

170. The termination of the authority of an agent causes Termination the termination (subject to the rules herein contained agent's regarding the termination of an agent's authority) of the authority. authority of all sub-agents appointed by him.

Agent's Duty to Principal.

Agent's duty in conducting principal's business.

171. An agent is bound to conduct the business of his principal according to the directions given by the principal, or, in the absence of any such directions, according to the custom which prevails in doing business of the same kind at the place where the agent conducts such business. When the agent acts otherwise, if any loss be sustained, he must make it good to his principal, and, if any profit accrues, he must account for it.

Skill and diligence required from agent. 172. An agent is bound to conduct the business of the agency with as much skill as is generally possessed by persons engaged in similar business, unless the principal has notice of his want of skill. The agent is always bound to act with reasonable diligence, and to use such skill as he possesses; and to make compensation to his principal in respect of the direct consequences of his own neglect want of skill or misconduct, but not in respect of loss or damage which are indirectly or remotely caused by such neglect, want of skill or misconduct.

Agent's accounts.

173. An agent is bound to render proper accounts to his principal on demand.

Agent's duty to communicate with principal. 174. It is the duty of an agent, in cases of difficulty, to use all reasonable diligency in communicating with his principal and in seeking to obtain his instruction.

Right of principal when agent deals on his own account, in business of agency without principal's consent. 175. If an agent deals on his own account in the business of the agency, without first obtaining the consent of his principal and acquainting him with all material circumstances which have come to his own knowledge on the subject, the principal may repudiate the transaction, if the case shows either that any material fact has been dishonestly concealed from him by the agent, or that the dealings of the agent have been disadvantageous to him.

Principal's right to benefit gained by agent dealing on his own account in business of agency.

176. If an agent, without the knowledge of his principal, deals in the business of the agency on his own account instead of on account of his principal, the principal is entitled, notwithstanding anything contained in Part VIII of this Law, to claim from the agent any benefit which may have resulted to him from the transaction.

177. An agent may retain, out of any sums received on Agent's account of the principal in the business of the agency all retainer out moneys due to himself in respect of advances made or of sums expenses properly incurred by him in conducting such principal's business, and also such remuneration as may be payable account. to him for acting as agent.

178. Subject to such deductions, the agent is bound to Agent's duty pay to his principal all sums received on his account.

to pay sums received for principal.

179. In the absence of any special contract, payment for the performance of any act is not due to the agent until the remuneracompletion of such act; but an agent may detain moneys tion becomes received by him on account of goods sold, although the whole of the good consigned to him for sale may not have been sold, or although the sale may not be actually complete.

When

180. An agent who is guilty of misconduct in the business entitled to of the agency is not entitled to any remuneration in respect of that part of the business which he has misconducted.

Agent not remuneration for business misconducted.

181. In the absence of any contract to the contrary, an agent is entitled to retain goods, papers and other property, whether movable or immovable, of the principal received property. by him, until the amount due to himself for commission, disbursements and services in respect of the same has been paid or accounted for to him.

Agent's lien principal's

Principal's Duty to Agent.

182. The employer of an agent is bound to indemnify Agent to be indemnified him against the consequences of all lawful acts done by against consuch agent in exercise of the authority conferred upon him. sequences of lawful acts.

183. Where one person employs another to do an act, Agent to be and the agent does the act in good faith, the employer is against conliable to indemnify the agent against the consequences of sequences of that act, though it cause an injury to the rights of third good faith. persons.

acts done in

184. Where one person employs another to do an act Non-liability of employer which is criminal, the employer is not liable to the agent, of agent to either upon an express or an implied promise, to indemnify do a criminal him against the consequences of that act.

Compensation to agent for injury caused by principal's neglect.

185. The principal must make compensation to his agent in respect of injury caused to such agent by the principal's neglect or want of skill.

Effect of Agency on Contract with Third Persons.

Enforcement and consequences of agent's contracts. 186. Contracts entered into through an agent, and obligations arising from acts done by an agent, may be enforced in the same manner, and will have the same legal consequences, as if the contracts had been entered into and the acts done by the principal in person.

Principal how far bound when agent exceeds authority.

187. When an agent does more than he is authorised to do, and when the part of what he does, which is within his authority, can be separated from the part which is beyond his authority, so much only of what he does as is within his authority is binding as between him and his principal.

Principal not bound when excess of agent's authority is not separable. 188. Where an agent does more than he is authorised to do, and what he does beyond the scope of his authority cannot be separated from what is within it, the principal is not bound to recognise the transaction.

Consequences of notice given to agent.

189. Any notice given to or information obtained by the agent, provided it be given or obtained in the course of the business transacted by him for the principal, shall, as between the principal and third parties, have the same legal consequences as if it had been given to or obtained by the principal.

Agent cannot personally enforce, nor be bound by contracts on behalf of principal.

Presumption of contract to contrary.

- 190. (1) In the absence of any contract to that effect, an agent cannot personally enforce contracts entered into by him on behalf of his principal, nor is he personally bound by them.
- (2) Such a contract shall be presumed to exist in the following cases—
 - (a) where the contract is made by an agent for the sale or purchase of goods for a merchant resident abroad;
 - (b) where the agent does not disclose the name of his principal;
 - (c) where the principal, though disclosed, cannot be sued.

191. (1) If an agent makes a contract with a person who Rights of neither knows, nor has reason to suspect, that he is an parties to a agent, his principal may require the performance of the made by contract; but the other contracting party has, as against agent not disclosed. the principal, the same rights as he would have had as against the agent if the agent had been principal.

(2) If the principal discloses himself before the contract Where is completed, the other contracting party may refuse to principal fulfil the contract, if he can show that, if he had known who himself was the principal in the contract, or if he had known that before the agent was not a principal, he would not have entered of contract. into the contract.

192. Where one man makes a contract with another, Performance neither knowing nor having reasonable ground to suspect of contract that the other is an agent, the principal, if he requires the supposed to performance of the contract, can only obtain such perform- be principal. ance subject to the rights and obligations subsisting between the agent and the other party to the contract.

193. In cases where the agent is personally liable, a Right of person dealing with him may hold either him or his principal, person dealing with or both of them, liable.

agent personally liable.

194. When a person who has made a contract with an conseagent induces the agent to act upon the belief that the quence of inducing principal only will be held liable, or induces the principal agent or to act upon the belief that the agent only will be held liable, principal to he cannot afterwards hold liable the agent or principal that respectively.

principal or agent will be held exclusively

- 195. A person untruly representing himself to be the Liability of authorised agent of another, and thereby inducing a third pretended person to deal with him as such agent, is liable, if his alleged employer does not ratify his acts, to make compensation to the other in respect of any loss or damage which he has incurred by so dealing.
- 196. A person with whom a contract has been entered Person into in the character of agent is not entitled to require the tracting as performance of it if he was in reality acting, not as agent, but agent not on his own account.

entitled to performance. Liability of principal inducing belief that agent's unauthorised acts were authorised. 197. When an agent has, without authority, done acts or incurred obligations to third persons on behalf of his principal, the principal is bound by such acts or obligations if he has by his words or conduct induced such third persons to believe that such acts and obligations were within the scope of the agent's authority.

Effect, on agreement, of misrepresentation or fraud by agent.

198. Misrepresentations made, or frauds committed, by agents acting in the course of their business for their principals, have the same effect on agreements made by such agents as if such misrepresentations or frauds had been made or committed by the principals; but misrepresentations made, or frauds committed, by agents, in matters which do not fall within their authority, do not affect their principals.

Section 247 of this Law which repealed the Commercial Code (Amendment) Law 1917 and some provisions of the Mejelle and the Ottoman Commercial Code, provided that such repeal should not, and that nothing in the Law should, affect:—

- (a) any contract, agreement, bond or instrument entered into, made or executed before the coming into operation of this Law; or
- (b) any right or interest acquired or accrued under the provisions of any enactment repealed by this Law; or
- (c) any legal proceeding or remedy in respect of any such contract, agreement, bond, instrument, right or interest.
